HONORING JANET JAGAN 2009 GUYANA FOLK FESTIVAL AWARDS

WHEREAS, IT IS THE SENSE OF THIS LEGISLATIVE BODY TO HONOR JANET JAGAN FOR EXCEPTIONAL SERVICE TO THE COMMUNITY AND STATE UPON THE OCCASION OF THE 2009 GUYANA FOLK FESTIVAL AWARDS CELEBRATION; AND


